

# **"ALL IN FOR THE WIN" Promotion** COVID-19 Vaccination Promotion: July 8, 2021 – August 26, 2021

## **Drawing Rules**

- 1. **PROMOTION PERIOD:** The \$10 Million "ALL IN FOR THE WIN" COVID-19 Vaccination Promotion ("Promotion") begins with the first drawing on July 8, 2021 and ends with the last drawing on August 26, 2021 (the "Promotion Period").
- 2. ADMINISTRATORS: For purposes of these Official Rules, "Illinois Lottery" or "Lottery" shall mean the Illinois Department of the Lottery, "Manager" shall mean Camelot Illinois, LLC acting in its capacity as private manager or its successor designated by the Illinois Lottery, and "IDPH" shall mean the Illinois Department of Public Health. The Illinois Lottery and IDPH shall collectively be referenced as the "Administrators." The Administrators with the manager shall collectively be the "Promotion Entities." The Promotion is administered by the Administrators.
- **3. AGREEMENT TO THE OFFICIAL RULES:** By participating in the Promotion, all players fully and unconditionally agree to and accept these Official Rules and the decisions of the Administrators as final and binding in all matters related to the Promotion. Winning a Prize (defined below) is contingent upon fulfilling all requirements set forth herein.
- 4. **ODDS:** The odds of winning a prize for each Drawing of the Promotion are dependent upon the number of eligible Entries received from IDPH for each drawing.
- **5. HOW TO ENTER:** For each Drawing: Entries, which are automatic when an individual meets the eligibility requirements (as defined in Section 6) prior to 11:59 PM Central Time (in these Rules, all times are Central Time) at least seven (7) days prior to each Drawing during the Promotion Period ("Entry" or "Entries").

#### Entries are only those as defined above.

- 6. **ELIGIBILITY:** The Promotion is open to individuals who meet the following requirements:
  - at least 18 years of age for Cash Prizes or between the ages of 12 17 for Scholarship Awards at the time of the draw;
  - resident of Illinois (regardless of immigration status);
  - have received, at a minimum, one dose of the COVID-19 vaccine in Illinois (except for vaccines administered at certain federal facilities, e.g. U.S. Bureau of Prisons); and
  - have had their vaccine information received and accepted as valid by I-CARE (as defined in Appendix C).

# An individual must meet all eligibility requirements seven (7) days prior to a Drawing in order to qualify for automatic entry for that Drawing.

The Federal government will not provide IDPH with a list of Illinoisans who were vaccinated at certain Federal facilities (e.g. U.S. Bureau of Prisons), so these individuals are not eligible. It is not possible for individuals to

submit their records to IDPH. I-CARE is updated by healthcare providers, including pharmacies that received Federal funds to implement their COVID-19 vaccination programs (e.g. CVS and Walgreens).

For those who received a COVID-19 vaccine at a federal Department of Veterans Affairs facility:

- Each week the U.S. Department of Veterans Affairs ("DVA") will send IDPH a data file containing the DVA ID number, Age Group, and Restore Region code per eligible DVA patient. This data will be included for all successive lottery draws.
- Should a DVA patient number be drawn, IDPH will share the DVA ID number with the DVA and DVA will use the ID Number to identify the individual in their system. DVA will contact the patient and obtain the signed Authorization Form, and share the signed Authorization Form with either the Lottery or Treasurer.
- Should the winner decline or not be eligible, DVA will notify IDPH and they will proceed with the process for contacting alternates.

In addition, the following persons are not eligible to enter this Promotion or claim a prize: (a) any member of the Lottery Control Board ("Board"), any employee of the Illinois Lottery, any employees of the Manager, (b) any officers, contractors, or employees of IDPH who participated in the creation or administration of the Promotion, any employees or officers of the Office of the Governor or Lieutenant Governor; (c) any officer, official, contractor or employee who assisted in the creation of this Promotion, or in carrying out any of the Drawings (d) officers and employees of audit firms performing service for the Illinois Lottery in administering the Drawings for the Promotion; and (e) any spouse, child, or family member residing as a member of the same household in the principal place of residence of any person designated in (a) – (d); any participant in the Lottery's Voluntary Exclusion Program or individual who has otherwise requested in writing to be excluded from this Promotion. This Promotion is void where prohibited by law.

7. PRIZES AND THE VALUE OF THE PRIZES: The Administrators are offering a \$10 Million prize pool for the ALL IN FOR THE WIN Promotion, \$7 Million in Cash Prizes and \$3 Million in Scholarship Awards. Between July 8, 2021 and August 26, 2021, the IDPH and the Lottery will conduct a series of nineteen (19) drawings for Cash Prizes, two (2) Statewide \$1,000,000 Drawings with three (3) winners (one drawing will have two winners and one drawing with one winner), six (6) Statewide \$100,000 Drawings with three (3) winners per Drawing, and eleven (11) Regional \$100,000 drawings with two (2) winners per Restore Illinois Region (defined in Appendix B).

During the Promotion Period, the Lottery will also conduct a series of thirteen (13) drawings for Scholarship Awards in Bright Start College Savings Program accounts [owned by the Office of the Illinois State Treasurer ("Treasurer") on behalf of the winner] valued at \$150,000, two (2) Statewide drawings and eleven (11) Regional drawings with one winner per Restore Illinois Region (as defined in Appendix B).

#### An individual may only win one (1) Prize during the Promotion.

8. WINNER SELECTION: For each Drawing during the Promotion, IDPH will provide the Illinois Lottery with the total number of Entries for that Drawing (the "Pool") as well the number of selections to be made (the winner and a number of alternates). Each vaccinated individual is anonymized by number assigned by IDPH. For each Drawing during the Promotion, the Lottery will conduct the Drawings using a random number generator based on the parameters provided by IDPH.

A Drawing is a single drawing within the Promotion. Note that drawing, Drawing or Drawings may refer to any random selection event and subsequent matching of the number drawn to the Entry in the Pool. All winners of Cash Prizes must be 18 years of age or older and all winners of Scholarship Awards winners must be between the ages of 12-17 on the date of the draw.

For each Drawing, the Lottery will provide IDPH the winning numbers generated. IDPH will match the winning numbers to the corresponding Entry to identify the winner(s). IDPH will contact the winner(s) of each Drawing and request the winner(s) complete and return an ALL IN FOR THE WIN Promotion Authorization Form ("Authorization Form") permitting IDPH to disclose to the Lottery or the Treasurer the individual's name, address, email address, telephone number(s), and COVID-19 vaccination status. The winner(s) will have seven (7) days from the draw date to complete in its entirety and return the executed Authorization Form to IDPH. The Lottery requires this information to confirm a winner's eligibility and to validate their entry. If the winner chooses not to claim the prize, does not respond to IDPH's attempts to contact them or the winner does not complete the Authorization Form in its entirety and return it within the specified time, the winner will be disqualified from that Drawing and the process will be repeated with the first alternate winner, and if necessary, a successive alternate until the Prize is accepted.

Should all alternates be exhausted without a winner claiming the Prize, the Administrators reserve the right to determine the winner through another randomized drawing from the same pool, excluding those already selected as a winner or alternate. The drawing date and structure will be determined by the Administrators.

When IDPH receives the winner's completed Authorization Form within the specified time, IDPH will notify the Lottery or the Treasurer of the winner's name, address, email address, telephone number(s), and COVID-19 vaccination status.

IDPH will not provide the Lottery or the Treasurer with the personal identifying information of any vaccinated individual prior to a winner signing an Authorization Form. IDPH will not provide the Lottery any personal identifying information of any vaccinated individual who is the winner of a Scholarship Award. A winner may choose to remain anonymous at the time of claiming the Prize. For those selecting anonymity, their city or county will still be provided to the public. The city will be made public for winners who reside in towns with a population greater than 20,000 and for those in towns smaller than this amount their county will be made public.

**9.** WINNER NOTIFICATION: If an individual's Entry is selected in a Drawing for a Cash Prize, IDPH will contact the individual by phone and/or e-mail. In order to receive their Prize, the winner is required to complete, sign, and return an Authorization Form with a copy of his/her personal identification to IDPH.

If an individual's Entry is selected in a Drawing for a Scholarship Award, IDPH will contact the parent or guardian of that individual by phone and/or email. The individual and the parent/guardian will fill out the necessary forms to claim the prize. No information will be provided to the Illinois Lottery for Scholarship Awards.

**10. CLAIMING:** Winners must claim their prize by **4:30 PM of the claiming deadline date** as identified in the Drawing Schedule (see Appendix A) and as otherwise described within these Rules. Failure to do so will result in disqualification and an alternate winner may be selected. A decision to replace a winner with an alternate is within the sole discretion and judgment of the Administrators. After the Administrators decide to proceed with an alternate, the person who was previously selected as a winner is no longer entitled to the prize.

Alternate winners must claim by **4:30 PM on the claiming deadline** as identified in the Drawing Schedule (see Appendix A).

A selected winner or parent/guardian of a winner who is contacted and fails to complete the claims process by providing all information requested (e.g. age verification, address verification, a copy of his/her personal identification, including an executed Authorization Form) in the time required will forfeit the Prize and the next alternate winner will be selected. Moreover, the disqualified winner and any potential beneficiary may not assert any right or remedy on account of any disqualification, or other action. IDPH will determine if a winner will be allowed to receive a prize. In the event of a winner's death or inability to partake of the prize, the Administrators will make a determination about the awarding of the prize. The Administrators' decision will be final.

For Cash Prizes, checks will be provided by the Comptroller of Illinois's Office.

For Scholarship Awards, the Treasurer will contact the winner(s) parent/guardian to obtain the pertinent information necessary to set up a 529 Scholarship Account. As part of the 529 Scholarship Account set-up process, the winner(s) parent/guardian may have to provide additional information about the parent/guardian and the child. Before establishing the 529 Scholarship Account, the parent/guardian must also review and approve of the complete policies and procedures for 529 Scholarship Accounts. All 529 Scholarships will be invested in a Bright Start College Savings Program scholarship account owned by the Treasurer on behalf of the winner(s) To keep account information secure, only certain individuals authorized by the Treasurer will be allowed to give instructions for the disbursement of funds (e.g. request a distribution) with respect to the account. Both the Treasurer and the winner will receive Bright Start guarterly statements. The winner may use the scholarship funds toward the payment of gualified higher education expenses, for attendance at an "eligible educational institution" as those phrases are defined in the Internal Revenue Code, 26 U.S.C. 529. Generally, gualified higher education expenses include tuition and fees, room and board, books, computer, internet, and other expenses required during years the winner is enrolled at an eligible educational institution. An eligible educational institution includes most accredited public, nonprofit, and privately-owned for-profit postsecondary institutions. When the winner incurs gualified higher education expenses, he/she may submit a withdrawal form (available at www.brightstart.com) to the Treasurer to request payment directly to his/her eligible educational institution.

11. GENERAL PRIZE AND PROMOTIONAL OFFER RESTRICTIONS: The Promotion is subject to change. No substitution is allowed by winner. The Promotion and prize are not exchangeable or otherwise transferable. The Administrators reserve the right to substitute the prize in whole or in part with other prizes of comparable or greater value, if the intended prize is not available for any reason, as determined by the Administrators in their sole discretion. Any transportation and/or lodging incurred in claiming the prize are not included. The winner(s) will be exclusively and solely responsible for all costs and expenses associated with Promotion prize redemption and prize acceptance and use not described as being provided, including but not limited to any expenses incurred by claiming or accepting a Promotion prize or award. The Promotion is governed by and shall be construed in accordance with Illinois law and is subject to all applicable federal, state, and local laws and regulations. Winner(s) are solely and exclusively and responsible for all taxes, including income taxes for any prize won, including but not limited to federal, state, and local taxes. The winner(s) will be required to provide his or her Social Security number or Taxpayer Identification Number (TIN) and appropriate tax documentation for tax reporting purposes. Winner(s) will receive a W-2G form for the prize won. All amounts or values paid to winner(s), or paid on their behalf, will be included in the taxable income which will be reported on your W-2G. The winner(s) will be taxed on those amounts. The minimum required Federal and State taxes will be withheld from all cash prizes over \$5,000; additional amounts may be owed. Further, if you win a prize and you owe any State Obligations, then the cash prize will be applied first to your unpaid State Obligations. The total amount of cash won, less tax withholdings and any State Obligations will be issued to you. "State Obligation" includes, but is not limited to, child support and debt owed to a State agency or other governmental entity. In accordance with the Internal Revenue Code, 26 U.S.C. 117, Bright Start 529 Scholarships, if used for gualified tuition and related expenses, do not incur tax liability to the beneficiaries, based upon current federal tax law, which is subject to change. Expenses associated with housing and dining costs (room and board) may be taxable income to the beneficiary, based upon current federal tax law, which is subject to change.

**12. GENERAL CONDITIONS AND RELEASE:** The Promotion is subject to applicable laws and regulations. By claiming a Promotion prize or award, each winner (a) agrees to defend, indemnify, release, and hold harmless the Promotion Entities, and each of their respective owners, parents, affiliates, subsidiaries, directors, officers,

agents, employees, managers, licensees, distributors, dealers, retailers, printers, representatives, advertising and promotion agencies, and any and all other companies associated with the Promotion, and all of their respective officers, directors, employees, agents, and representatives (collectively, the "Released Parties") from and against any and all claims, causes, costs, injuries, losses, or damages of any kind that may occur, directly or indirectly, in whole or in part, arising out of the redeemer's redemption of the Promotion or receipt or use of any prizes, including, but not limited to: (i) unauthorized human intervention in the Promotion; (ii) technical errors related to computers, servers, providers, or telephone or network lines; (iii) printing errors; (iv) lost, late, postage-due, misdirected, or undeliverable mail; (v) errors in the administration of the Promotion or the processing of entries, including but not limited to data entry errors resulting from or caused by the entering, keying, or mis-keying of the required information by redeemers; (vi) injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from redeemer's redemption of the Promotion or receipt or use of any Promotion; (vii) the unauthorized or illegal access to personally identifiable or sensitive information or the acceptance, possession, use, or misuse of any prize or any travel or activity related to the receipt or use of any prize; (b) may agree to grant the Promotion Entities and each of their respective designees a worldwide, royalty-free, perpetual, irrevocable, non-exclusive right and fully licensable license to use, copy, reproduce, distribute, publish, publicly perform, publicly display, modify, adapt, translate, archive, store, and create derivate works from entrant's post (including any images) in whole or in part, in any form, format, or medium, of any kind now known or later developed; (c) may provide consent for the Promotion Entities and each of its respective designees to use the winner's name, hometown, photograph, voice, or other likenesses and prize information for promotion, advertising, and marketing purposes in any media or format now known or hereafter devised, throughout the world, in perpetuity, without additional compensation, consideration, notification, or permission, unless prohibited by law, and upon request will provide written confirmation of such consent; and (d) acknowledges that none of the Promotion Entities or anyone else has either made, or is in any manner responsible or liable for, any warranty, representation, or guarantee, expressed or implied, in fact or in law, relative to any prize including, but not limited to, its quality or availability and ALL SUCH WARRANTIES ARE DISCLAIMED IN THEIR ENTIRETY. Neither any of the Promotion Entities nor any of their service providers are responsible for incorrect or inaccurate transcription of entry information; any human or other error, technical malfunctions; lost or delayed data or voice transmission; omission; interruption; deletion; defect; line failures of any telephone network, computer equipment, or software; inability to access any online service or website or to complete a telephone call or facsimile transaction; any other error or malfunction; late, lost, or misdirected mail; or any injury or damage to an entrant's or any other person's computer related to or resulting from participation in the Promotion.

Neither the Promotion Entities nor their agents and representatives, owners, parent companies, affiliates, subsidiaries, advertising, promotion and fulfillment agencies, and legal advisors are responsible for and will not be liable for: (a) late, lost, damaged, misdirected, incomplete, unintelligible, or postage due entries; (b) telephone, electronic, hardware or software program, network, internet or computer malfunctions, failures or difficulties of any kind; (c) failed, incomplete, garbled, or delayed computer transmissions; (d) any condition caused by events beyond their control that may cause the Promotion to be disrupted or corrupted; (e) any injuries, losses, or damages of any kind arising in connection with or as a result of the Promotion, acceptance, possession, redemption, or from participation in the Promotion; or (f) any printing or typographical error in any material associated with the Promotion. If any discrepancy should exist between these Official Rules and any promotional material describing the Promotion, these Official Rules shall govern.

**CAUTION:** ANY ATTEMPT BY A PARTICIPANT OR ANY OTHER INDIVIDUAL TO DAMAGE ANY WEBSITE ASSOCIATED WITH THE PROMOTIONAL OFFER, TAMPER WITH THE CLAIMING PROCESS, OR OTHERWISE UNDERMINE THE CONTENT OR LEGITIMATE OPERATION OF THE PROMOTIONAL OFFER MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, ADMINISTRATORS WILL DISQUALIFY ANY SUCH PARTICIPANT, AND ADMINISTRATORS AND THE APPLICABLE PROMOTION ENTITIES AND THEIR RESPECTIVE AGENTS RESERVE THE RIGHT TO SEEK DAMAGES (INCLUDING ATTORNEYS' FEES) AND OTHER REMEDIES FROM ANY SUCH REDEEMER OR INDIVIDUAL(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW. No failure to enforce any term of these Official Rules shall constitute a waiver of that provision. These Official Rules may be modified for clarification purposes without materially affecting the terms and conditions of the Promotional Offer. If for any reason the Promotion (or any portion thereof) is not capable of being executed as planned, or in the case of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, action of entrants, technical failures, or any other causes that, in the opinion of Administrators, corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Promotion (or any portion thereof), the Administrators reserve the right in their sole discretion to disqualify any suspect participant or winner and/or to cancel, terminate, modify, or suspend the Promotion (or any portion thereof). Any winner(s) that claims a Promotion prize or award via a fake account (e.g., bot account) will be disqualified. Administrators reserve the right in their sole discretion to cancel the Promotion in its entirety, if it becomes technically corrupted or because of non-authorized human intervention. In the event of any disqualification of a suspect participant or winner, notice thereof will be posted. Winner(s) not complying with all rules are subject to disqualification. In the event of any termination, cancellation, or suspension, notice thereof will be posted on the Promotion website.

- **13. APPLICABLE LAWS**: All participants agree to comply with and abide by all applicable laws, including the Illinois Lottery Law (20 ILCS 1605/1 *et seq.*) and the Illinois Department of Public Health Powers and Duties Law (20 ILCS 2310-1 *et seq.*), the College Savings section of the State Treasurer's Act (15 ILCS 505/16.5), administrative rules and regulations, instructions, conditions and final decisions of the Administrators and all procedures established by the Administrators for the Promotion In the event of a conflict between these Official Rules and any summary, representation, or other restatement of rules appearing in any advertisement, point of sale material, tickets or other media, these Official Rules shall govern. In the case of a conflict or contradiction between or among the Illinois Lottery Law, the Department of Public Health Powers and Duties Law, the Illinois Lottery Administrative Rules (11 III. Admin. Code Part 1775) and these Official Rules, the Illinois Lottery Law and Administrative Rules shall control. The Administrators do not waive sovereign immunity rights provided under law and nothing in these Official Rules shall be interpreted to constitute a waiver of the Administrators' sovereign immunity rights.
- 14. DISPUTE RESOLUTION: Except where prohibited by law, by redeeming, Promotional Offer redeemers agree that in the event of a dispute concerning the construction, validity, interpretation, or enforceability of these Official Rules, the determination of the Administrators shall be final and binding. All issues and questions concerning the rights and obligations of participant(s) in relation to the Promotion Entities and their agents shall be governed by and construed exclusively in accordance with the laws of the State of Illinois without giving effect to any principles of conflicts of law of any jurisdiction. Redeemer agrees that any such action at law or in equity shall be filed only in the state or federal courts located in Chicago, Illinois, and redeemer hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such action. EXCEPT WHERE PROHIBITED BY LAW, BY CLAIMING A PROMOTION PRIZE OR AWARD, EACH WINNER AGREES THAT: (A) ANY AND ALL DISPUTES, CLAIMS, AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE PROMOTIONAL OFFER SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; AND (B) ANY AND ALL CLAIMS, JUDGMENTS, AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, INCLUDING COSTS ASSOCIATED WITH CLAIMING THE PROMOTION PRIZE OR AWARD BUT IN NO EVENT ATTORNEYS' FEES; AND (C) UNDER NO CIRCUMSTANCES WILL ANY PARTICIPANT BE PERMITTED TO OBTAIN AWARDS FOR AND HEREBY WAIVES ALL RIGHTS TO CLAIM PUNITIVE, INCIDENTAL, AND CONSEQUENTIAL DAMAGES; ANY OTHER DAMAGES, OTHER THAN FOR ACTUAL OUT-OF-POCKET EXPENSES; AND ANY AND ALL RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED.

## Appendix C

#### **I-CARE** Definition

I-CARE, or Illinois Comprehensive Automated Immunization Registry Exchange, is a web-based immunization record-sharing application developed by the Illinois Department of Public Health (IDPH). The application allows public and private healthcare providers to share the immunization records of Illinois residents with other physicians statewide. I-CARE is designed to help healthcare providers record, track, and report their patients' immunizations. The registry allows physicians to access patient records for information about immunizations administered outside their practices. Provider participation is voluntary and not all providers within the state choose to participate in the registry. Patient participation is also voluntary. Patients wishing not to have their information included in the registry may opt-out at their provider.
